#### 9:00-A Welcome from TriMet General Manager Doug Kelsey 9:15 Doug Kelsey has worked at TriMet since 2015 and was appointed TriMet's General Manager in 2018. Before joining TriMet, Doug served as Chief Operating Officer at TransLink in Vancouver, B.C., and president of the bus and rail companies. He was directly responsible for the transportation plans for the Vancouver Olympic and Paralympic Games, and he has supported the strategic plans of other Olympic Games, including London and Sochi. #### 9:00- C-TRAN Mill Plain BRT Project Virtual Tour

10:00 The Mill Plain BRT project extends approximately ten miles from Downtown Vancouver to near Mill Plain Blvd. &192<sup>nd</sup> Ave. in East Vancouver, with 37 stations and one new transit center. The Mill Plain Blvd. corridor has C-TRAN's second-highest transit ridership, making it the logical next step for bus rapid transit in Clark County after the successful implementation of the Vine in 2017. The project is expected to open in fall 2022. C-TRAN will present its in-house produced virtual tour of the project, and make "stops" along the way to answer questions and provide additional detail.

 10:00 **Tofino-Ucluelet Transit: A Unique Service Design for B.C.'s West Coast** 10:45 Melissa Coates, Transportation Coordinator The remote west coast of Vancouver Island is home to the thriving communities and popular tourist destinations of Tofino and Ucluelet. The growth of these communities and their environmental stewardship has ignited the desire to realize the development of a robust multi-modal transportation system across their region. The introduction of a public transit route is a key element of their strategy to help tackle summertime congestion issues and promote transit as a viable option to travel for work or pleasure across the key attractors of each town and to visit the pristine west coast beaches that dot the route along the journey. In collaboration with local governments, First Nations communities, and Parks Canada, a new service has been designed to support essential travel for residents and provide multi-modal options for tourists. The Tofino-Ucluelet Service Plan considers the viability of having surfboards on buses while balancing the need to provide a safe and viable fixed route transit service their communities.
